



AL-HIKMAH UNIVERSITY UNVEILS TWO BOOKS IN MEMORY OF LATE JUSTICE ORIRE

he Centre for Islamic Heritage, Al-Hikmah University on Saturday, 14th May 2022 launched two books titled: Essential Manual for Dawah Practitioners and A New Guide to the Principles and Practice of Mirath in Nigeria, at the University Auditorium.

The Vice Chancellor, Al-Hikmah University who doubled as the Chief Host of the event, Prof. Noah Yusuf in his speech remarked that Al-Hikmah University is the first institution to give a befitting posthumous honour to Hon. Justice Abdulkadir Orire CON who was the most senior Muslim scholar in Ilorin Emirate and one of the leading voices of Islam in Nigeria.

Prof. Yusuf also noted that the University appreciates his legacy as the Pioneer Grand Khadi of Kwara State Shariah Court of Appeal and the first Sarkin Mallami of Ilorin Emirate. He prayed that Almighty Allah

continue to grant Late Justice Orire's soul eternal rest and make Jannat Firdaus his final abode. He added that the efforts at honouring the Jurist posthumously will not end with the event; rather the University is committed to the continuous training of Muslim clerics, missioners and leaders of Muslim organisations on dawah and Islamic estate distribution through certificate programme in dawah and imamship practice and professional certificate in Islamic estate distribution.

The Director, Centre for Islamic Heritage, Prof. Shuayb Ologele Assayouti, while delivering his speech, pointed out that the two books were compiled after much agitation from scholars and students who are convinced that both books would ameliorate dearth of reading materials in the areas captured.

According to Prof. Assayouti, "many have written on Muslim Law of

Succession both in Arabic and English, the present work is peculiar with practical aspects and professional requirements in the Nigerian context". He added that the late Justice during his life time was one of the leading Muslim intelligentsia in the field of Dawah and Sharia and no one could have deserved this honour more than him.

Barr. Musa Abdulkadir Orire, one of the sons of the Late Justice, while giving his vote of thanks, expressed gratitude to the entire editors of the book, Prof. Lateef Oladimeji, Dr. Sikiru Adenigba, Dr. Abdullahi Ishola and Mallam Waliyullah Adeyemi; the organising committee and the entire Al-Hikmah University community for making the book launch a memorable event. He also prayed that Almighty Allah replenish the pockets of all those that have spent in the course of making the day a reality.

WE HAVE MORE CASES OF MALARIA IN TROPICAL AREAS - DR. ADEYEMI

he Acting Head, Al-Hikmah University Health Services, Dr. Bashirat Adeyemi has stated that tropical places like Africa and some countries in Asia record more cases of malaria because mosquitoes thrive well and breed in humid environment.

The Acting Head said this during an interview session with the Information Crew in her office on Friday, 20th May, 2022. Dr. Adeyemi said that malaria fever is a form of infection caused by bite of female anopheles mosquito which then transmits plasmodium which is the cause of the infection. She added that we have 1.5 million cases of malaria per year and most of these cases are recorded during the raining season.

According to the medical doctor, "malaria symptoms start manifesting few weeks after the bite and some of its symptoms in adults are, high body temperature, dehydration, headache, general body pains, cold, nausea while for children the symptoms can

manifest in different forms as their bodies are not well coordinated". In addition to the symptoms listed for adults, she said the symptoms in children include cough, abdominal pain, weakness and loss of blood.

Dr. Adeyemi pointed out that most medical practitioners start diagnosing malaria by asking questions from the patients and if some of these above signs are noticed by them especially if the patients say the symptoms are more exhibited in the evening, such medical practitioner can carry out a Rapid Diagnostic Test (RDT) or a more effective test in the laboratory to know the exact stage of infection. She added that the next thing is treatment after diagnosis and the most encouraged treatment for malaria fever by the global health organizations is artemisinin-based combination therapy (ACT), which is a combination of drugs to cure malaria fever. But if the patient cannot tolerate tablets, injections are complemented with ACT.


In her words, "sometimes complications can set in especially from vulnerable groups like children, pregnant women and travellers coming in from countries that do not have cases of malaria. In order to avoid this complications, pregnant women and travellers are given prophylactic anti malaria". She added that we can prevent malaria by reducing chances of sustaining mosquito bite. To do this we need to clear stagnant water, cut bushes around our houses, use mosquito repellant cream, use insecticides, use insecticide treated nets or ordinary nets if we are allergic to the treated nets.

Dr. Adeyemi urged the government to help reduce malaria by subsidising drugs and insecticide and to intensify effort in the distribution of treated nets and ACT drugs for children and pregnant women. Also, the government should increase the number of environmental officers moving around for inspection.

RELIGIOUS UNDERSTANDING IS VITAL TO ACCEPTING OTHER PEOPLE'S FAITH - PROF. OLADIMEJI

Humanities and Social Sciences, Prof. Abdulateef Folorunsho Oladimeji has revealed that religious understanding will make individuals not to trample on another person's religious right, belief or obligation because it is their philosophy. He made this revelation during an interactive session with the Information Crew in his office on Wednesday, 18th May, 2022.

Prof. Oladimeji pointed out that blasphemy which is the use of abusive or derogatory words against an exalted person or an institution or a particular set of people is a crime in Islam that is not taken lightly.

According to him, "an Islamic scholar named Ahmad Deedat, has said that biggest enemy of Islam is the ignorant Muslim, whose ignorance leads him to intolerance and whose actions destroy the true image of Islam. When people look at him they think that Islam is what he is." What happened is Sokoto is unfortunate and condemnable because there is no room for jungle justice in Islam. In fact, Prophet Mohammed (SAW) used to pray for those who speak wrong against him and pray to Allah to guide them because they did not know what they were saying. He added that the Sokoto incident could have been resolved intellectually by inviting Deborah and educating her about Islam. Who knows? She might have accepted Islam from such peaceful dialogue!

The Dean emphasised that to discourage the barbaric act in the future, the Ulamah need to sensitise

the public on the true picture of Islam in order to discredit misinterpreted and distorted understanding of verses of the Quran. Also, let them know that people will say things in favour of their religion and sometimes against them and their religion and when they do the



latter, they should avoid any violent confrontation. Rather, they should have a peaceful discussion. This dawah should be taken to the door step of every school, youth, elite, woman,

worker and professional.

Similarly, a visiting lecturer in Al-Hikmah University, Prof. Rasheed Ijadola (SAN) noted that Nigeria as a secular state gives freedom of expression to individuals but we have to respect each other's religious views and inclinations.n his words "blasphemy is a judicial matter that should be tried in Sharia Court and if the person is guilty, such person would be punished by the law and not by people that carry out jungle justice". He added that though there is freedom of speech in the country, that does not give anyone the right to disrespect other people's religion.

Similarly, Barr. Isa Olawale

Solahudeen, a lecturer in the Department of Islamic Law, Faculty of Law defined blasphemy as irreverence towards God; or contempt for God, religion, religious icon, or something else considered sacred. He stated that there are relevant provisions under the Nigerian Law which do not only declare blasphemy as an offence, but also punish the offender. He added that among the applicable criminal laws in Nigeria are Penal Code, which operates in the North, which stipulates that a blasphemer shall be punished with imprisonment for a term which may extend to two years or with fine or with both; and Criminal Code, which is applied in the South. It stipulates that a blasphemer is liable to imprisonment for two years.

Barr. Solahudeen however stressed that the available punishment for a blasphemer under the Sharīah is death. However, this particular penalty available under Sharia can only be imposed on the blasphemer whether a Muslim or otherwise by a competent court of law. Hence, taking laws into one's hands and engaging in jungle justice have no place under the Islamic Law.

According to him, "there is no uniform law binding every nation regarding the offence of blasphemy as the form of regulatory responses to address blasphemy against any religion ranges from imprisonment to fine, lashing or execution". He added that countries that punish blasphemers by imprisonment, fine, lashing or execution can be said to operate similar law for blasphemy like Nigeria.

MORAL DECADENCE FLOURISHES IN A SOCIETY THAT IS CARE FREE - MALLAM AHMAD

Department of Religious and Islamic Studies, University of Ilorin, Mallam Yahya, Shaykh Ahmad has pointed out that that moral decadence flourishes in the society when moral values deteriorate. Mallam Ahmad said this at a Jihad Week programme organised by Al-Hikmah Students Da'wah Committee (ASDAC) titled "Re-awakening the Muslim Youth in Nigerian Tertiary Institutions from Moral Decadence" on Wednesday, 25th May 2022 at the University Auditorium.

According to him, "Islam, like many other religions in the world, emphasises the necessity of living in the world that is devoid of forms of immorality including, but not limited to sexual harassment, excessive materialism, alcoholism, drug abuse, fornication, adultery, indecent dressing, homosexuality, robbery, corruption, examination malpractice, terrorism and banditry". He lamented the unfortunate spate of social vices; which in consequence has continuously has estranged piety, kindness, honesty, trustworthiness, humility, respect, probity, and integrity among young and old alike.

Mallam Ahmad attributed the cause of moral decadence to indiscriminate importation of Western ways of life, indoctrination of Muslim youths by the allies of secessionism, inordinate ambition for accumulation of wealth, lack of parental care, unrestricted accessibility to social media, bad leadership and lack of religious knowledge. According to him, the effects of moral decadence are insecurity, human trafficking, high rate of materialism, religious syncretism and injustice. Therefore, he enjoined Muslim youths to shun all acts of immorality because they are means of defiling Allah and Prophet's (S.A.W) injunctions.

The guest speaker noted that in order to nurture a decent society that is free from moral deterioration, Allah instructed mankind to be good in utterance and action. He highlighted the benefits of maintaining a decent society as follows: it aids communion between man and God; it expiates the sins committed by man, assists the person that put up good character to be prosperous with the divine love, it is the most virtuous of all acts of worship, it guarantees elongation of life span and comfortable livelihood, it

serves as an indicator to the perfection of faith of a servant. It fosters unity, brotherhood and humanitarian services among people and it is one of the acts of worship that pave way for the hitch-free admission into paradise. In his words, "some of the ways to boost moral standard are good creed, supplication, striving towards it, self-evaluation, turning away from mischievous people, reflection on the life and teachings of Prophet (S.A.W) Muhammad and the righteous people".

The Amir of ASDAC, Abdulfatai, Abdulfatai, AbdulRahman Omodele who is a final year student in the Department of Science Education, in his remarks stated that the sole purpose of ASDAC is to propagate Da'wah in the University. He reiterated the commitment of ASDAC to this, so as to guide students to the right path and make them good ambassadors of the University.

Mr. Abdulfatai thanked the Management and the Centre for Islamic Heritage for making the Dawah week a successful one and he prayed for Allah's guidance and blessing at all times.
